 and all of its lien rights and/or payment bond rights relating to the undersigned's improvements to the Property;
- The undersigned Lien Claimant, for the undersigned and any person or entity with which it has contracted for any
 portion of the materials supplied or labor provided, hereby releases Hendrick Construction, Inc. ("General
 Contractor") from all claims, actions and matters of whatever kind, whether known or unknown, accrued or
 unaccrued, relating in any way to the labor, services and/or materials furnished to the Property;
- The undersigned Lien Claimant warrants and represents that all persons, partnerships, firms, entities or corporations, including, without limitation, all subcontractors or suppliers, who have furnished labor, materials and/or equipment to the Lien Claimant for use in the improvements to the Property have been paid in full; and
- The undersigned agrees to indemnify and hold harmless General Contractor from any and all losses, costs or expenses which General Contractor may incur on account of the representations contained in Paragraphs 3 and 4 above.
